Taking the unifying intent of all the 2024-28 Vision's priorities in the round, and in recognition of a current and over-lapping public consultation on Spatial Strategy and Policies Directions for the next Local Plan to 2040, we note with appreciation that the latter includes Policy IC10 "Former Lewes to Uckfield Railway Line" as an element in the Infrastructure & Community Facilities theme. In order to reflect that emerging policy commitment in the Council's Corporate Plan for 2024-28, recognising the socio-economic and environmental benefits which rail already brings to the wider area, and that those benefits could be further embedded by restoring a rail link between Lewes and Uckfield, we advocate inclusion of the following additional element within the 'Creating sustainable community wealth' priority of the final 2024-28 Vision:

We will develop opportunities to enhance long-term community prosperity through improved public transport connectivity, by supporting further work on developing the business case for restoring a Lewes-Uckfield rail link, to allow the strategic, economic and environmental case and the implications of restoring such a link to be more fully evaluated.

It will be seen that this supports Priority 4 "A great place to live and work" within the 'Community Wealth and Wellbeing' theme.
