The Railway Development Society Limited Election of Directors for 2016/17

The Board of Directors is legally liable for the running of the company, RDS Ltd, which is the legal name for Railfuture, and must abide by the Companies Act, Data Protection Act, Health and Safety at Work Act, and many other pieces of legislation. It also has a legal duty to act in the best interests of the members, which primarily means ensuring that Railfuture is financially well-run and is not exposed to unnecessary risk.

Although Railfuture exists to campaign for a bigger and better railway, the responsibility of the Board of Directors is to manage the society to enable high-quality, modern, professional and effective campaigning work, where relevant to the aims of the society, to be done by Railfuture volunteers, and to make available funds to do so where appropriate and value-for-money. It is not the immediate responsibility of the directors to campaign, although many do so within their branch activities, and it is not necessary for every director to have a deep understanding of the railway.

The board needs a variety of knowledge, understanding and skills amongst the directors that include: company management, project management, finance/accountancy, corporate governance, data protection, legal, human resources, information technology (especially web-sites and databases), as well as railway matters, both as rail users and professionals working within the rail industry.

Chris Hyomes - Election Address

I have been an active pro-rail campaigner since 1982, cutting my teeth with the Friends of the Settle to Carlisle line association in their fight to keep the Settle and Carlisle line open. It was through my work with the friends that I became a member in 1983 of Railfuture or the Railway Development Society as it was then known.

I became Yorkshire Branch Chairman and Media spokesperson in 2008. Since that time I have built up a very good and close working relationship with many representatives of Yorkshire based media to the extent that I am now often called up on to provide advice and background information before they decide to publish or broadcast a Rail based story.

On joining the board three years ago I quickly learnt that as a director you need to have both campaigning and business management skills I anm fortunate in having over 30 years' experience in both disciplines, from within my working life.

One of the biggest issues facing Railfuture is how we grow our membership base, making it more representative of today's rail users. One of the areas I am keen to help branches develop is social media.

<u>Ian McDonald - Election Address</u>

I have been a transport campaigner for some 36 years, mainly with Railfuture, but also with Transport 2000, Green Party, and other organisations. I was principal editor of Railfuture's re-issued book, 2Britain's Growing Railway2 produced in 2010 (A-Z of Line Re-openings), with update being planned now for 2016, and produced policy papers on many topics including Electrification, Eurostar, other international rail services, and the HS2 project, representing Railfuture at relevant conferences. I am a member of the groups working to convince Ministers to continue to invest significantly in railways, with some success in recent years, as well as with TOCs on proposed franchising bid contents, timetable changes, and with NR on infrastructure updates and programming. Our efforts for more electrification have finally paid off.

I am concerned that we should listen to any expressed branch concerns about our rail campaigning work, and ensure that our funds are well used to help campaigns where justified. We badly need to recruit more young members and motivate them to join.

We have helped to make impact on political and public awareness of the extent of carbon emissions in transport and costs of increased traffic congestion, and can be proud that we have successfully raised our profile with more press coverage on fare increases, electrification programmes, reopening closed lines, and investing in high speed rail as an alternative to more airport runways, and motorway construction. I have played a leading role in preparing some of our position papers, consultation submissions, and press releases. I will continue to help press Railfuture campaigns and agreed collective policies if Government and transport bodies lose momentum.
