COVID-19 briefing to Railfuture members



The Railfuture *Rail Network Announcements Pipeline* (RNAP) saw just one of last month's four awaited DfT decisions, <u>continuing two incumbents' operations</u> from 1st April. <u>Southeastern</u> will continue to be operated by Govia, and <u>Great Western Railway</u> by FirstGroup.

Three Decisions for Transport remain outstanding:

- ~ the Williams Rail Review
- ~ the Fares and Ticketing Review
- ~ GTR's Passenger Benefit Fund results.

Happy railway birthdays in April:

~ Tuesday 27 April 2010 marked the first step towards the conclusion of a double decade of campaigning for the East London Line Extensions. A one month long 'preview service' ran between the four new stations at Dalston Junction, Haggerston, Hoxton, and Shoreditch High Street and New Cross / New Cross Gate. Joint usage has multiplied four-fold, from 5.4 to 22.1 million.



- ~ responded to **Hertfordshire County Council**'s consultation on its <u>draft Rail Strategy</u> which closed on Monday 30 March.
- ~ participated in **Transport for the South East**'s meeting of its Transport Forum on Tuesday 31 March, which considered reports of the consultation on, and proposed amendments to, the <u>draft Transport Strategy</u>.

What shall we be doing (out there)?



Department for Transport's consultation on Closure of Newhaven Marine station closes on Sunday 19 April.


