~ on the 23<sup>rd</sup>, Stevenage, in 1973 (second station, a mile south of the original – below – opened in 1850 and closed to coincide with its successor's opening).

~ on the 25<sup>th</sup>, in 2015, a 'soft opening' to passengers of London Overground's Hackney Interchange walkway.
