Our proposals

1 Please let us have any comments about our proposals, including how these may impact you whether in a positive or negative way.

Comments:

We are broadly content with the current proposals to be taken forward in 2023 to an application for an Order under the Transport & Works Act.

Our principal concerns are firstly that any extension beyond Lewisham is not necessary in order to support the new homes and jobs in the Old Kent Road Opportunity Area or much of the New Cross / Lewisham / Catford Opportunity Area, secondly that an extension beyond Lewisham is likely to overload the central section of the Bakerloo line (see our response to question 16 in the 2014 consultation), and thirdly that the location, design and construction of the Lewisham platforms and tunnels and of the Wearside Road facility must not preclude (or increase the cost/difficulty of) construction of a new route through Lewisham between Docklands and Croydon (see part 3 of our response to question 19 in the 2014 consultation).

2 Please let us have any comments on our proposals for a new combined Bakerloo line and Northern line ticket hall at Elephant & Castle station.

Comments:

Developing our 2014 response as already noted above, we do not regard further extension of the Bakerloo line from Lewisham to Hayes as the only never mind the best way to realise the objectives declared for it, it is likely to have a detrimental impact of the functioning of the line in the central area, and it would preclude the development of an alternative scheme with wider benefits for south-east and east London, and beyond.
