17. *Please use the box below if you would you like to tell us a bit more about your answer to this question:* Network Rail's Wales and Western Region 2024 report "Connecting Communities: framework assessment of new station opportunities on Western Route" examined settlement or population clusters where the total population within a connected settlement cluster living more than 5km (3 miles) away from a railway station was greater than 10,000 people. Of the hundreds of clusters identified nationally 29 are on, or closest to the infrastructure of, Western Route. Six, including the Cowley branch line, were not considered further as already subject to advanced business case development or had recently been subject to detailed industry-led business case development. Of the other 23, three are in Oxfordshire - the 2nd-highest by national cluster size rank is Witney (19th), followed by Carterton (45th) and Wantage/Grove (82nd). In the overall assessment of feasibility (a combination of strategic fit and complexity) of the 23, Witney ranked 8th, Wantage 9th, and Carterton 21st. Carterton is ranked 4th-equal and Witney 6th for strategic fit, Wantage 19th. Wantage and Witney share 8th place in the combined rank as, unlike Witney, Wantage has the benefit of location on an existing line; Carterton is in 21st place. As the report itself notes, however: "Carterton presents an interesting case. Its strategic case score is among the highest, but it scores lowest in likely complexity (i.e. it is the most complex of all opportunities studied). This reflects the need for a long section of new railway and a new service. It should be noted that the proposal for Carterton includes a station at Witney (a separately identified cluster) so the Carterton strategic case and likely complexity scores include Witney." It is noteworthy that these three places have not been excluded, as have others, on this basis: "Clusters which may be expected to have a strong case for a new station in future but do not currently, for example where significant housing or employment growth is allocated or proposed." In summary, Network Rail has clearly identified Wantage and Witney-Carterton as meriting their own new mainline stations.

strengthened by a 15-year Plan for Rail at a time of multiple institutional and policy changes, positioning the authority as equipped - across a period of uncertainty - to respond to challenges and grasp opportunities. Considering the importance of increased capacity on the very busy line through Oxford and bearing in mind that every single proposal in the Plan is dependent on such capacity, save only the potential new station at Ardley, we consider it vital to keep the number of trains terminating at Oxford to a minimum to reduce platform occupation. The Council should therefore seek to ensure that passenger services to / from the EWR route should extend to / from Didcot and / or Bristol thus also increasing frequencies and improving connectivity on these routes.
